NOTICE IS HEREBY GIVEN of the municipality's intentions to solicit the views of the local community, businesses, CBOs, NGOs, organized labour and other interested or affected persons; in accordance with sec 78(3)(a) of the Municipal Systems Act, 2000 (hereafter referred to as "the MSA, 2000").

The City of Johannesburg Metropolitan Municipality **is reviewing the existing outsource delivery mechanism** for the provision of fleet services in accordance with the MSA, 2000. Although fleet services do not fall into the legislative definition of municipal services, the function by its very nature "as a *vehicle of service delivery*" is essential for the provision of municipal services such as municipal law enforcement, emergency services (firefighting and health); refuse removal etc.
